The YMCA of Iredell County is offering an after school program for the 2009-2010 school year. The program is designed for boys and girls in Kindergarten – 12 years old. The program is located at North view Elementary.

Policies and Procedures

Pick-up

The program is officially over at 6:00 pm each day. There will be a \$5 late fee for each minute after 6 pm for each child that is picked-up late. This fee must be paid in cash. Your child will not be allowed to return until this late fee is paid.

Please call 704-873-9622 x- 225 if you are going to be late to let us know.

Operating Schedule

Our program operates on the ISS schedule. We will try to offer our services on other school system schedules. We cannot guarantee we will be able to operate or we may be limited to a smaller number of participants based on our ratio of counselor to camper.

Attendance

If your child will not be attending on certain days, you will need to call and let us know. This way, we are not waiting for your child at the school. If your child is sick and you have a doctor's note you will be given credit. If you do not have a doctor's note or if you are on vacation, no credit will be given. We do not give credit for dentist appointments of any kind. We take attendance everyday. Once you sign up for the afterschool program you are reserving a spot for your child for the entire year. You will be billed for this amount whether your child attends or not. We cannot switch money from our afterschool program to other programs.

If your child is expelled or suspended from school, he/she will not be allowed to attend afterschool until he/she is allowed to return to school.

If you wish to cancel your registration for YAfterSchool, you must speak to Susan Evans or Chris Cox **ONLY**, **give a written request** and give a 2 week notice. You will be responsible for payment of 2 weeks after canceling your child's registration.

Payments

Payments can be made by:

1. Electronic Fund Transfer (EFT): Payments for After School will be made by EFT. These payments may be made weekly, biweekly, or monthly. Please see Susan Evans if you need specific dates.

A reminder that the afterschool program fee is due the Friday before the week your child is enrolled in the program. **If payment is not made by 6:00 pm on Friday, a \$10 late fee will be added to your weekly payment.**

Swim Days

Your child will need to bring a bathing suit and towel on his/her swim day. We will let you know our swim schedule later on. Please label your child's belongings and urge them to try to keep up with his/her things.

Things Not to Bring

We do not allow children to bring toys, radios, CD players, video games, etc. to the YMCA Afterschool Program. When children bring these items they tend to disappear and usually are not seen again. We realize that these are valuable items and ask that they be kept at home.

Things to Bring

- Tennis shoes - Please bring or wear tennis shoes. Children are not allowed to play in the gym when wearing sandals. We do not want anyone to get hurt and sandals tend to cause children to fall easily.
- Weather appropriate clothing - We plan to go outside. Please plan accordingly. Jackets and coats will be needed as the seasons begin to change.
- We will send notes home to let you know of anything special we may plan to do as they come up.

Snow Day Policy

The YMCA of Iredell County has implemented the following policy for inclement weather:

When school is dismissed due to snow, sleet, or freezing rain, the YMCA will NOT pick up the children at school.

A message will be left on the answering machine at the YMCA if the Y is closed due to weather. This message will advise you when the Y will be open and what programs will be running. A decision will be made by 8 am.

Short School Weeks

On school scheduled short weeks, (anything less than 5 days) there will be **NO** \$5 discount for the second or third child. We will adjust the price of the short weeks according to the number of days. See chart below.

3 Days: \$31.20
2 Days: \$20.80
1 Day: \$10.40

Potential Member Daily Rates:

5 Days: \$82.00
4 Days: \$65.60
3 Days: \$49.20
2 Days: \$32.80
1 Day: \$16.40
